## Tuition:

Tuition payments are due the 1st week of each month, the first months tuition is due upon registration.

Payments made 5 days or more after due date will incur a \$5.00 late fee for each week it is late. Tuition may be paid in cash, check, or credit card and are non refundable unless the class is cancelled.

## Refund Policy:

Tuition is non refundable unless Serious injury or illness occurs. A credit or refund will be given with a written notice from doctor stating the inability to continue a dance class.

## Cancellation of Classes:

We will cancel classes if the New Berlin School Districts cancel school or their after school activities.

## Cancelled Classes:

Classes with less than three students may be cancelled or rescheduled at Dance N' Company's discretion.

## Photo Release:

The studio is hereby granted permission to take photos of the students to use in brochures, studio website, advertisements, or any other promotional material. Permission is also hereby granted for the studio to copyright photos in our name.

## Dress Code:

Shoes and practice wear can be purchased through Discount Dance Catalog, Trep Art or Target.

Ballet shoes for Ballet, Jazz shoes for Jazz, Tap shoes for Tap, Street shoes for Hip Pop. Shoes can be purchased and ordered thru the Studio at the front desk. Shoes are very important to have. They provide support for the dancers. Correct shoes can help avoid injury.

## Attendance & Tardiness:

Good attendance is imperative as absenteeism can affect the progress of the class as a whole. Dancers can severely hurt themselves if they are not properly stretched, due to attending class late. If a dancer misses 5 or more classes after January , the student may not be allowed to participate.

## Insurance:

Theresa's Dance N' Company does not carry medical insurance for its' students. It is required that all students be covered by their own family insurance policies.

## Newsletters:

A monthly newsletter will be sent home with the youngest dancer in each family. This will contain important information so it is imperative that *Parents Read These Newsletters As They Come Home.*
